Transport Scotland is the national transport agency for Scotland and is accountable to Parliament and the public through Scottish Ministers, with a budget of around £2 billion per year. Transport is a vital feature of the Scottish Government's focus on increasing sustainable economic growth, and transport investments and policies have major impacts on the economy, people, and the environment.

Transport Scotland is starting a period of transition, with the completion of a number of major infrastructure projects and a greater emphasis on the promotion of air quality, active travel, accessibility, and the development of the low carbon economy. This is underpinned by the development of a new National Transport Strategy covering Scotland's transport needs and priorities for the next 20 years. The recent Programme for Government and the agency's corporate plan set out a range of associated activities.

Applications are invited for an Environment and Air Quality Manager. The post is in the Environment & Sustainability team within the Roads Directorate of Transport Scotland. In this post, you will lead on a variety of issues associated with the Low Emission Zone (LEZ) policy of the Scottish Government. You will be part of a team that oversees air quality and LEZ actions associated with transport.

The Environment & Sustainability team takes a strategic overview across the environmental & sustainability work of Transport Scotland. This is an exciting opportunity for anyone with a particular enthusiasm for transport policy, planning and analysis at a time when there is a real opportunity to help shape the future of transport in Scotland.

Essential Criteria

1. Demonstrable knowledge of environmental management at strategic and policy levels.

2. Proven record of delivering complex, time-bound projects simultaneously across a diverse workload whilst managing competing technical demands from internal and external stakeholders.

3. Excellent people management skills, with experience of building strong and effective relationships with senior people.

4. Experience in the analysis and development of technical environmental solutions that inform decision making around new policy development or project delivery.

Main Duties

• Lead the engagement with, and collaboration between, a range of stakeholders such as local authorities, environmental and health statutory bodies including SEPA and Health Protection Scotland, private sector stakeholders and third-sector organisations to; facilitate delivery of the Programme for Government commitment to put in place LEZs in Scotland's 4 biggest cities by 2020; support local authorities to put in place a back-office system to administer LEZ enforcement and; manage data collection and analysis associated with LEZ preparation and operations.

- Lead the delivery of the LEZ communications strategy.
- Provide specialist advice on air quality legislation and interlinkages between air quality, LEZs and health.

• Manage LEZ governance arrangements including the LEZ Leadership Group and LEZ Delivery Groups for Scotland's four main cities.

• Oversee transport aspects of the Cleaner Air for Scotland strategy. This will encompass supporting the Cleaner Air for Scotland Review transport working group and participating in the Cleaner Air for Scotland governance group.

• Support the implementation of the National Low Emission Framework.

• Manage all financial aspects of LEZs including leading the determination of funding/grants to public and private sector organisations and preparing an annual Spending Review submission around the LEZ budget.

• Lead the procurement processes necessary to implement PfG Air Quality/LEZ commitments on Scottish road networks.

• Participate in the development of future PfG LEZ/Air Quality commitments.

• Support the development of new LEZ legislation in the Transport (Scotland) Bill and rollout of Programme for Government commitments such as the LEZ support fund and real-world air quality remote sensing.

• Assist on research projects being taken forward by, or supported by, Transport Scotland in relation to air quality.

• Provide oral and written advice to Ministers, Scottish Parliament committees and Transport Scotland Directors in tandem with contributing into, and signing-off, briefings, Parliamentary Questions, Ministerial correspondence and FOI requests.


