ROAD TRAFFIC

The A83 Trunk Road (Tarbert) (30mph Speed Limit) Order 2007

Made	2 nd May 2007
Coming into force	16 th May 2007

The Scottish Ministers, in exercise of the powers conferred by section 84(1)(a) as read with section 124(1)(d) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling them in that behalf, and having complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b), hereby make the following Order:

Citation and commencement

1. This Order may be cited as the A83 Trunk Road (Tarbert) (30mph Speed Limit) Order 2007 and shall come into force on 16^{th} May 2007.

Restriction of speed

2. No person shall drive any motor vehicle at a speed exceeding 30mph on the length of road specified in the Schedule to this Order.

3. The following Orders are varied in accordance with the following paragraphs:

a. The County of Argyll (Built up Areas) Order 1960 is hereby varied to the effect that the part of the First Schedule relating to Tarbert (South) is deleted.

b. The Strathclyde Regional Council (Restricted Roads) (Transitional) Order 1985 is varied to the effect that the part of Schedule 1 Reference AR/A83-2 Tarbert is deleted.

SCHEDULE

That length of the A83 Tarbet – Lochgilphead - Kennacraig Trunk Road at Tarbert from a point 28 metres or thereby northeast of the centreline of the access road to The Ridge, southwestwards then westwards, then southwestwards to a point 60 metres or thereby southwest of the centreline of Glen Park, a distance of 1.4 kilometres or thereby.
