### **ROAD TRAFFIC**

# The A77 Trunk Road (Auchencrosh to Ballantrae) (40mph Speed Limit) Order 201[]

Made - - - - - - Coming into force - -

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 84(2)(**b**) of that Act, they have given public notice of their intention to make the following Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(**c**).

#### Citation and commencement

**1.** This Order may be cited as the A77 Trunk Road (Auchencrosh to Ballantrae) (40mph Speed Limit) Order 201[] and comes into force on 201[].

#### Speed restriction

2. No person may drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in the schedule.

#### Exemption

- 3. No speed restriction imposed by this Order applies to—
  - (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(d) when used in accordance with regulation 3(5) of those Regulations; or

## SPECIFIED LENGTH OF ROAD

That length of the A77 Glasgow – Stranraer Trunk Road from a point 50 metres or thereby north of The Kennels, northwards to a point 88 metres or thereby south of the southern end of the bridge parapet of Ballantrae Bridge, a distance of 4118 metres or thereby.
