Background

The Disabled Persons' Parking Places (Scotland) Act 2009¹ ("the Act") was passed by the Scottish Parliament on 26 February 2009, receiving Royal Assent on 1 April 2009, and coming into force on 1 October 2009. The Act places a duty on all local authorities to promote the proper use of disabled parking places, and aims to make all disabled persons' parking bays enforceable.

Under the Act, local authorities have duties to identify all advisory disabled parking places and either remove them or begin the statutory procedure to make them enforceable. The Act states that this duty was to be performed within 12 months of the coming into force of the Act (by 30 September 2010).

The Act also places a duty on local authorities under section 11 and the Scottish Ministers under section 12 to publish annual performance reports. Part 1 and Part 2 of the Schedule² to the Act details what the reports should include.

Local Authorities' Duty under section 11

Section 11 of the Act requires a local authority to prepare, publish and send to Scottish Ministers a copy of, 'a report on its performance of its functions in relation to parking places for disabled persons' vehicles during the reporting period.' Part 1 of the Schedule specifies what information the report should contain.

Scottish Ministers' Duty under section 12

Section 12 of the Act requires Scottish Ministers to prepare, publish and lay before the Scottish Parliament, 'a report on the performance by the local authorities of their functions in relation to parking places for disabled persons' vehicles during the reporting period.'

Part 2 of the Schedule to the Act details what the Scottish Ministers should include in their report. This is provided at **Annex A for reporting period 2018/19**.

The preparation, publication and laying of this report will fulfil those requirements for the reporting year 2018/19 and cover the period from 1 April 2018 to 31 March 2019. The Scottish Ministers' reports are published on the Transport Scotland website³.

Scottish Ministers' reporting duties

The following information is reported as a requirement of section 12 of the Act. The following information should be read in conjunction with the Schedule⁴ to the Act.

1 Schedule, Part 2, paragraph 3 (a)

'Details of the action that each local authority took in fulfilment of its duty under section 1'.

Local authorities reported the following information under paragraph 3 (a) in respect of the reporting period:

Aberdeen City Council

- Aberdeen City Council continues to process applications for disabled persons' parking places where criteria are met. Advisory disabled persons' parking places are provided until the statutory process is completed. Aberdeen City Council also removes any disabled persons' parking place that is no longer required.
- Blue Badge holders, when requesting a disabled parking facility are fully advised of the regulations, that they are open to any Blue Badge holder and that the badge requires to be displayed at all time
- Aberdeen City Council enforces all disabled persons' parking places governed by a Traffic Regulation Order (TRO) and has officers in place to investigate fraudulent use of Blue Badges

Aberdeenshire Council

 Aberdeenshire Council promotes the proper use of parking spaces for disabled persons' vehicles by routinely issuing excess charge notices to those using such spaces improperly in car parks covered by the Aberdeenshire Council (Off-Street Parking) orders. The number of such notices issued during the reporting period (2018-19) was 112 of which 30 were subsequently cancelled following successful appeals.

Angus Council

• Angus Council are continuing to process applications for new street disabled bays and where criteria is met then advisory bays are provided until the statutory process is completed. Disabled person parking places which are no longer required are removed.

Argyll & Bute Council

 nine temporary bays have been marked, however, the formal TRO process has not yet been started

City of Edinburgh Council

- staff within Parking Operations and the Localities Offices provide advice and the relevant application form to customers who wish to apply for a DPPP outside their home
- For new developments there are procedures in place to make the developer aware of the duty of local authorities to promote the proper use of parking places that are designated for use only by disabled persons' vehicles. As part of the planning process the developer is asked if they wish CEC to enforce disabled persons' parking places.

Clackmannanshire Council

• two Traffic Orders have been progressed this year. Work is ongoing to update records for all towns/villages.

Comhairle nan Eilean Siar

• a Disabled Persons' Parking Places Order was completed in August 2018 which updated the previous order with additional "off street" parking bays

Dumfries & Galloway Council

- processing applications as and when received
- review of TTRO's periodically

Dundee City Council

 information is available on the DCC website relating to the scheme, rights and responsibilities of Blue Badge holders. Press publications have also been released informing motorists of the increased budget made available to meet standards and maintain existing disabled spaces.

East Ayrshire Council

• on 28 January East Ayrshire Council made a new Disabled Persons' Designated Parking Places traffic Order revoking a previous Order made in 2015

East Dunbartonshire Council

• East Dunbartonshire Council continue to promote the proper use of parking places designated for the leaving of a vehicle displaying Blue Badges as require through the Disabled Persons' Parking Places (Scotland) Act 2009

East Lothian Council

advertising literature "Don't park in my space" has been displayed in all Council offices

East Renfrewshire Council

- in order to fulfil the Councils duty under section 1 of the Act the Council considered the method best suitable for delivering and maintaining disabled persons parking places within East Renfrewshire
- an electronic system to record locations of all enforceable disabled bays, both on-street and off street has been designed and is continuously maintained
- TRO's for On-street and Off-street DPPP's are promoted enabling enforcement of marked bays

Falkirk Council

• Falkirk Council considered all requests for disabled persons parking places by qualifying persons and has where possible commenced the statutory process to make Orders for those applicants

Fife Council

- the twelfth of the six monthly updates to the on-street traffic order schedules was made on 9 August 2018 and the thirteenth amendment was made on 6 March 2019. The TRO was amended on each occasion to add the new bays and to remove bays which have since become redundant.
- on 14 March 2016 The Fife Council (Disabled Persons' Off-Street Parking Places) Order 2016 was made with an operational date of 4 April. This Order makes disabled bays enforceable in car parks that are not maintained by Transportation Services. This could include Housing Service parking areas, Education facilities e.g. schools (including PPP schools), libraries, community centres, etc. (As reported 2015/16).
- on 12 February 2019 an Amendment to the 2016 Off-street Order was made with an operational date of 1 March 2019 to make disabled bays enforceable for Community Services facilities in Levenmouth and Anstruther

Glasgow City Council

- the Council continued to receive and grant applications for the provision and repaint of disabled parking bays by qualifying persons
- all new developments have been checked and where necessary developers will be contacted and invited to participate

Highland Council

 decriminalised parking enforcement is currently rolling out throughout the Highland Council area. This rollout is helping to capture disabled bays that were installed but not previously included in the traffic regulation order. These bays have now been included in this report. In addition the Highland Council have surveyed existing disabled bays and regulated the sizes and layouts, meaning they now conform to current TSRGD and are enforceable.

Inverclyde Council

- Inverclyde Council promotes the creation of parking places for disabled persons through an on-line application process on the Council's website
- with the introduction of Decriminalised Parking Enforcement throughout Inverclyde, Orders were created to regulate Off-Street car parks and include Disabled Persons' Parking Places. The consultation and publicity processes served to highlight the provision of Disabled Persons' Parking Places within the car parks.

Midlothian Council

- all pre-existing on-street bays have been identified, assessed and made enforceable by inclusion in a TRO
- all off-street bays for which the Council is responsible for have been identified, assessed and made enforceable by inclusion in a TRO
- new applications are being processed as fast as resources permit. As Midlothian Council is a decriminalised parking area the Council enforces both individual and groups of disabled spaces at community hubs.

Moray Council

 following the process undertaken previously, to identify all historic advisory disabled parking spaces, the council have been assessing all new applications over the most recent reporting period (1/4/2018 to 31/3/2019) in accordance with the Act and supporting advice. The Traffic and the Blue Badge Teams continue to provide ad-hoc advice on the use of Blue Badge Spaces.

North Ayrshire Council

North Ayrshire Council continues to process applications when required. An
advert was issued in the local press inviting owners of private car parks to have
their bays included in a future order – unfortunately, we received no expressions
of interest following this. We are currently working with local housing associations
to provide guidance and expertise in relation to the application process with the
goal of including their bays in a future off-street parking order.

North Lanarkshire Council

- North Lanarkshire Council has continued to assess requests for disabled persons' parking places and promoted a number of Traffic Regulation Orders to allow the use of parking spaces to be enforced by Police Scotland
- advisory markings have been placed at requested locations initially and will remain in place until procedures to promote Traffic Regulation Orders are complete allowing permanent signs and markings to be provided

Orkney Islands Council

• the council has identified both on-street and off-street parking places

Perth & Kinross Council

• parking attendants regularly inspect and enforce the bays to ensure the proper use of the parking places for disabled persons' vehicles

Renfrewshire Council

- Renfrewshire Council has made its fifth Disabled Persons' parking Place On-Street Order on 9 November 2018 containing 125 new disabled parking bays
- the council is now completing its proposals for its sixth disabled persons' parking place on-street order containing 193 new disabled persons' parking bays
- the council is also now commenced working on its seventh On-Street Traffic Regulation Order
- the council also proposed to re-engage with all existing premises with off-street disabled persons parking places in the near future to determine if the landowners now wish these to be made enforceable by the Council

Scottish Borders Council

• we ensure staff in the traffic and road safety section are aware of the proper use of disabled parking places. We also issue reminder letters to the applicant

following any reports of a parking bay being used improperly. We have guidance on our local authority website detailing proper use of a parking bay.

Shetland Islands Council

- the council provides information through various sources in order to reach as many in the community as possible
- the council web page highlights eligibility, the statutory process and application forms with all relevant information
- local weekly newspaper (The Shetland Times) to highlight all stages of the statutory process
- all new developments are encouraged to participate in the provision of disabled parking bay(s)

South Ayrshire Council

• published information on Council web site. Promoted TRO covering proper use of disabled parking places on-street. Ongoing training of parking attendants to promote proper use of the parking places and blue badges through education and enforcement.

South Lanarkshire Council

• South Lanarkshire Council enforces the regulated disabled persons' parking bays in line with its policies and procedures

Stirling Council

- continue to assess all applications received for a disabled person's parking space under criteria which was amended following the introduction of the Disabled Person's Parking Places (Scotland) Act 2009 within 15 working days whenever possible
- where the applicant meets the criteria for a disabled person's parking space outside their property, we aim to arrange for the marking of an advisory space within ten working days of receiving their agreement on its location
- once the TRO process has been completed, arrange for the necessary signage to be erected
- on completion of the TRO the applicant's details are entered into a database to ensure a complete record is maintained
- Stirling Councils Traffic Regulation Orders and parking policy continue to allow vehicles displaying a Blue Badge to park free of charge and without time limit

within any "on-street" or "off-Street" pay and display parking area, in addition to any designated disabled parking spaces

• 58 disabled persons parking spaces were identified as being no longer required and were revoked following last year's review

West Dunbartonshire Council

• West Dunbartonshire has an up-to-date database for all on-street disabled parking bays; this identifies those already legally enforceable and those which are currently advisory only. This is constantly updated to include all new on-street parking bays. Each time a new TRO amendment order is implemented, the bays marked as advisory are automatically included in this schedule.

West Lothian Council

West Lothian Council has provided information through various sources in order to reach as much of the community as possible. The following methods have been used to convey information:

- information on the council web page at all times
- the back doors of council vans have been vinyl wrapped with a message promoting the correct use of disabled parking places

The following information has been provided by the local authorities mentioned below:

Argyll and Bute Council

"As with other local authorities, the budget reductions faced by Argyll and Bute Council over the last 10 years or so have resulted in a smaller workforce and a reduced ability to process requests as quickly as we would want. It may provide betterment if the legislation could be amended so that any disabled bays appropriately marked and signed were automatically enforceable. It would be a vast improvement even if this was only applied to off-street disabled bays."

Clackmannanshire Council

"Clackmannanshire Council are a small local authority where we do not have parking enforcement. We are still processing traffic regulation orders due to staffing levels and workloads, these are taking time.

Budget wise we only put plates up where disabled persons' parking places are getting misused or in busy areas."

Comhairle nan Eilean Siar

"At present a traffic regulation order is being processed which will include a total of 22 enforceable spaces. Initially it was hoped to have more bays in this order but on

inspection these bays were not suitable for inclusion. The order now includes bays out with Stornoway town centre."

East Dunbartonshire Council

"It should be noted that, in duties under Section 5(d)(iv), the 45 spaces where the process was started under section 5(3)(b) pertain to those which were identified in the previous reporting period (1 April 2016 – 31 March 2017).

At the time of submission, the return was incomplete as information from East Dunbartonshire Council's Planning Section had not yet been received in order to complete the Duties under Section 7 section of the report."

East Renfrewshire Council

"Due to other obligations & commitments and available resources, it has not been possible to promote an update to the current traffic regulation orders (TROs).

However, the promotion of an updated on-street TRO for 2018 has commenced and is anticipated to come into effect later in 2018."

Glasgow City Council

"The Council intends instigating discussions with Transport Scotland to seek to allow disabled bays to have the same status as bus stops, that is when they are signed on road they become enforceable."

Inverclyde Council

"9 disabled persons' parking places started the statutory procedure before the start of the reporting period and were revoked within the period.

7 disabled persons' parking places started the statutory procedure and were revoked within the period.

7 disabled persons' parking places started the statutory procedure to be revoked.

There are 566 current disabled persons' parking places which have been created by means of an Order since April 1996. This is in addition to the 40 created during this reporting period."

Midlothian Council

"Midlothian Council has been able to continue the employment of a member of staff specifically dealing with progressing traffic regulation orders. This has meant that three traffic regulation orders for a total of 117 disabled persons' parking places was completed in 2017/18. A steady stream of new applications is being received from disabled people who are experiencing difficulty in parking close to their homes (122 applications during 2017/2018).

Businesses in Midlothian were contacted during Autumn 2017 regarding disabled persons' parking places. No requests for Midlothian Council to enforce disabled persons' parking places in private premises were received during the consultation.

The new Act placed considerable extra responsibilities on local authorities. No additional funding was made available for signs and lines. However the Council is still able to assess applications reasonably quickly and the disabled persons' parking places are generally painted on the ground quite quickly depending on the availability of the road marking contractor. In most cases the presence of the initial "advisory" disabled road markings is enough to resolve any parking issues.

At the beginning of April, Midlothian became a decriminalised parking area. Midlothian Council are now responsible for parking enforcement, including the enforcement of disabled persons' parking places. "

Moray Council

"Due to staff shortages a traffic regulation order (TRO) has not been commenced yet to formalise all advisory disabled persons' parking places created during the reporting period. It is anticipated that this will commence in August 2018.

Once started it will have taken approximately 16 months to commence the process to introduce a TRO to make all new advisory spaces, created during the reporting period, legally enforceable and remove those spaces that have become redundant. It remains our intention to repeat this process every Autumn when resources permit."

North Ayrshire Council

"In the last reporting period North Ayrshire Council has undergone some re-organisation and the function of looking after disabled persons' parking places has transferred to a new member of staff, this has led to delays in starting the traffic regulation order to add the approved disabled persons' parking places since the last Order.

However, progress has been made with Housing colleagues who administer disabled persons' parking places not on the adopted road network to align procedures to make it seamless for the applicants as to how they apply and having the provided disabled persons' parking places enforceable under a Traffic Order. Similar work has been ongoing with a large Housing Association."

Renfrewshire Council

"Renfrewshire Council continues to carry out its duties under the Disabled Person's Parking Places (Scotland) Act 2009 as indicated."

Shetland Islands Council

"We recognise the problems many applicants have with increasing parking issues and we therefore contact an applicant almost immediately (within 1 week) to clarify qualification requirements and identify a suitable area for the space and begin the process.

As the local planning consent regulations do not stipulate a set number of disabled persons' parking places in new developments, we find no apatite from them to enter into an agreement with us (Shetland Islands Council) to start the statutory process."

Stirling Council

"To continue to liaise with Stirling Area Access Panel with regards disabled parking provision, whether that be new spaces or improvements to existing spaces on or off street.

Progress with respect of taking forward disabled persons' parking places implement and future enforcement within private car parks needs further analysis, and is still to be carried out, which is dependent on staff resources."
