Introduction

Transport Scotland and their consultant Atkins Mouchel Joint Venture (AMJV) are progressing a study into the potential non-motorised user links between the communities of Aviemore and Carrbridge. The Aviemore to Carrbridge Non-Motorised User (NMU) Route Study ("the Route Study") comprises a Baseline Assessment and a Route Options Appraisal.

In September 2019, as part of the Route Study, public exhibitions were held in Aviemore and Carrbridge to update interested parties on the progress of the Route Study and the outcome of the Baseline Assessment. The aim of the exhibitions was to engage with the public and offer the local communities an opportunity to see how the study is progressing and to provide comment on the options that are being taken forward to the Options Appraisal stage.

The Baseline Assessment and the public exhibition materials were prepared in consultation with key stakeholders such as The Highland Council, Cairngorms National Park Authority, HITRANS, Sustrans and Transport Scotland's Active Travel team.

The exhibitions were held in Aviemore Community Centre on Wednesday 25th September 2019 from 3.00pm to 8.00pm and Carrbridge Village Hall on Thursday 26th September 2019 from 2.00pm to 6.00pm.

Both exhibitions were well attended, with 152 attendees across the two days. This report summarises the scope of the event and the feedback received.



1. Public Exhibition Preparation

1.1. Advertising

In advance of the exhibitions, letters of invitation were sent to local Community Councils and NMU groups who were asked to distribute the letters of invitation to any mailing lists or forums they deemed appropriate. Similarly, invitations were issued to Cairngorms National Park Authority, The Highland Council, HITRANS and Sustrans, who were asked to distribute them to appropriate active travel and NMU organisations. A copy of the letter of invitation can be found at Appendix A. Further invites were issued to Historic Environment Scotland, SEPA, Scottish Natural Heritage and The Spey Fishery Board in their capacity as Statutory Consultees.

In addition, 150 posters advertising the event were distributed around post offices, churches, village halls, community centres, shops, libraries and schools. A copy of the poster can be found at Appendix B.

2. Public Exhibition Results

2.1. Attendance

The exhibition was well attended with a total of 152 visitors over the course of the two days, with 59 attending Aviemore on Wednesday 25th September and 93 attending Carrbridge on Thursday 26th September 2019.

In line with General Data Protection Regulations (GDPR), visitors were asked to complete a 'Register for Update' sheet on arrival at the exhibition. Registration was optional; however, most attendees provided their name and home postcode. An analysis of this information shows that the majority of visitors were from the Aviemore and Carrbridge postcode areas, refer to Figure 1 for the geographic spread of the registered attendees. In addition, 7% can be described as 'other' locations out with the areas highlighted below, with a further 4% not providing their home postcode.

2.2. Feedback Forms

A total of 113 pieces of feedback were received; a combination of feedback forms left on the day in Aviemore (11) and on the day in Carrbridge (29), completed online (41), submitted by post (25) and comments sent to the project email address (7).

The feedback forms included a series of survey style questions (questions 1-4) relating to the recipients use of a potential NMU route between Aviemore and Carrbridge. Question 5 provided an opportunity to make



2.2.1. Questions 1 – 4

Of the 113 pieces of feedback that were received, 106 were provided using the feedback form, and therefore answered the following questions.







Figure 2 above displays what respondents felt were important for an NMU route to provide. Of the 19 that ticked '*other*', the most common answers provided were Distance from Traffic (4), Least Impact on Wildlife (3), Creating a Circular Route (2) and Connecting Villages (2).










Figure 4 - Answers to Question 3 of the feedback form

Figure 4 above displays what respondents would use an NMU route for. Of the 25 that selected '*other*' the most common answers were Shopping (12), Sustainable Transport Links (4), Dentist (3), Doctors (3), Visiting friends and family (3) and Visitor Access to Villages (3).




Figure 5 - Answers to Question 4 of the feedback form

2.2.2. Question 5 (Comments)

Question 5 of the feedback form provided an opportunity for the public to provide comment and feedback on the material displayed at the public exhibitions to inform the Options Appraisal stage.

The key areas of feedback and comments that were received focused on; Safety, Directness, Comfort and Cohesion with other NMU links in the area. A copy of the feedback received, and the responses issued, can be found in Appendix H.





2.3. Summary

The Route Study exhibitions were held on 25th and 26th September 2019. The exhibitions provided an overview of the background of the study, the findings of the baseline assessment and outlined the next steps. This included details of the route corridors that had been assessed and confirmation of the two corridors to be progressed to the next stage of the assessment. The exhibitions provided an opportunity for members of the public to discuss the study with Transport Scotland representatives and their consultants, as well as providing an opportunity to provide formal feedback on the study.

The overall impression from discussions with members of the public was very positive, with the feedback received in the consultation period confirming this.

Following publication of the draft Orders for Transport Scotland's A9 Dualling Programme, Dalraddy to Slochd project on 28 August 2018, a number of formal objections were received. 

Baseline assessment – initial corridor identification and assessment



As part of the baseline assessment, a range of Non-Motorised User (NMU) corridors between Aviemore and Carrbridge were identified, based on a review of engineering and environmental constraints, existing NMU routes and a review of data received from the key stakeholders.

A total of ten corridors were identified, and these can be viewed on the drawings displayed here today.

All ten corridors were assessed against a range of criteria including:

Safety

Directness

Attractiveness

Comfort

- Cultural heritage
 Ecology and nature
- Cohesion with other cycle routes and transport connections
- Ecology and nature conservation
- Landscape and visual
- Water environment
- Property and land take
- Outline cost.

Following this assessment, eight corridors were sifted out based on potentially significant impacts.







 - A review of existing NMU routes and facilities in the study area
- Data collection from CNPA, THC, HITRANS, Sustrans and community councils
- NMU corridor identification and assessment
- Meeting with CNPA, THC, HITRANS and Sustrans
- Identification of corridors to progress to the options appraisal Public exhibition.

The key output of the baseline assessment was the publication of the Aviemore to Carrbridge Non-Motorised User (NMU) Route Study Baseline Assessment Report, this has been published on Transport Scotland's website: transport.gov.scot/active-travel/ aviemore-to-carrbridge-non-motorised-user-route-study

Baseline assessment – initial corridor identification and assessment

As part of the baseline assessment, a range of Non-Motorised User (NMU) corridors between Aviemore and Carrbridge were identified, based on a review of engineering and environmental constraints, existing NMU routes and a review of data received from the key stakeholders.

A total of ten corridors were identified and were assessed against a range of criteria includina:

- Safety
- Cohesion with other cycle routes and transport connections
- Directness
- Comfort
- Attractiveness
- Cultural heritage
- Ecology and nature conservation
- Landscape and visual
- Water environment
- Property and land take
- Outline cost.

Following this assessment, eight corridors were sifted out based on potentially significant impacts.


Therefore, two corridors are now proposed to progress to the options appraisal stage and are presented in this leaflet.

Full details of the assessment are included in the Aviemore to Carrbridge Non-Motorised User (NMU) Route Study Baseline Assessment Report.


