The Order as made provides for the purchase of the land described in the Schedule hereto, for the purpose of improving and constructing a new length of the M9/A9 Edinburgh – Stirling – Thurso Trunk between Tomatin and Moy in the County of Inverness-shire by widening and reconstructing the existing single carriageway to form a new dual carriageway section.

In accordance with the Coronavirus (Scotland) Act 2020, Schedule 6, Part 3, para 9, the proposed Orders and Plans will not be available for inspection at public display locations. The Order as made becomes operative on the 26th February 2021 being the date on which this notice is first published; but any person aggrieved by the Order may, in accordance with the provisions of paragraph 15 of the First Schedule to the Acquisition of Land (Authorisation Procedure) (Scotland) Act 1947 as extended by section 60 of the Land Compensation (Scotland) Act 1973, by application to the Court of Session within 6 weeks from that date, question its validity on the grounds (i) that the authorisation granted by the Order is not empowered to be granted, or (ii) that the application's interests have been substantially prejudiced by failure to comply with any statutory requirement relating to the Order.

The acquiring authority may acquire the land to which this notice relates by making a General Vesting Declaration under section 195 of the Town and Country Planning (Scotland) Act 1997. Such a declaration shall not be executed before the end of the period of two months beginning with the date of the first publication of this notice except with the consent of every occupier of the land affected. The effect of the making of such a declaration is to vest the land in the name of the acquiring authority at the end of the appropriate period and is more fully explained in Form 8 (Statement to be included in Form 4 where a general vesting declaration is to be made) contained in the Compulsory Purchase of Land (Scotland) Regulations 2003.
