The A830 Trunk Road (30mph Corpach and Banavie Primary School Part-time 20mph Speed Limit) Order 2006

Coming into force

19th January 2006 2nd February 2006

The Scottish Ministers, in exercise of the powers conferred by section 82(2)(a), 83(1) and 84(1)(a) and (c) as read with section 124(1)(d) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling them in that behalf, and having complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b), hereby make the following Order;

Citation and commencement

1. This Order may be cited as the A830 Trunk Road (30mph Corpach and Banavie Primary School Part-time 20mph Speed Limit) Order 2006 and shall come into force on 2nd February 2006.

30mph speed limit

2. Subject to article 3, no person shall drive any motor vehicle on the length of road specified in Schedule 1 to this Order at a speed exceeding 30mph.

Part-time 20mph speed limit

- 3. (1) No person shall drive any motor vehicle on the length of road specified in Schedule 2 to this Order at a speed exceeding 20mph when such speed limit applies to that length of road in accordance with paragraph (2).
- (2) A 20mph speed limit applies to the length of road specified in Schedule 2 to this Order when a 20mph speed limit is indicated by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations and General Directions 2002(c).

4. Paragraph 2 of the Schedule to The Fort William – Mallaig Trunk Road (A830) (Corpach) (40mph Speed Limit) Order 1993(a), is hereby revoked.

SCHEDULE 1

That length of the A830 Fort William – Mallaig Trunk Road at Corpach from a point 20 metres or thereby west of the centre line of Farrow Drive to a point 118 metres or thereby east of the centreline of East Tomonie Road, a distance of 1485 metres or thereby.

SCHEDULE 2

That length of the A830 Fort William – Mallaig Trunk Road at Corpach from a point 105 metres or thereby west of the extended west parapet of the railway bridge on West Tomonie Road, eastwards to a point 115 metres or thereby east of the extended west parapet of the railway bridge on West Tomonie Road, a distance of 220 metres or thereby.
