Yes

If you said "yes," what other issues with the moving around activity do you think need to be considered?:

I think there should be an increased emphasis on how often someone can or can't do a task, rather than either can walk x metres or can't walk x metres. Many disabled people can do a greater distance once in a while or when essential. The Award should be more holistic.

eg if someone is in danger they may be able to walk/move much further than the distance they can manage in normal daily life.

In your view, what are the positive aspects of the moving around activity that we have not captured above?:

see above. It all depends on the need, the mental capacity and personal attitude. Its the glass half full, not half empty syndrome.

When people arrive for a PIP assessment they are observed accessing the building, this is a very stressful situation but many people 'want to do their best' and frequently an application was rejected because this was a one off occasion, under stress when they managed more than x metres

I'm a little concerned about the standing definition. Some people who are double amputees have more balance and can walk further than a single amputee. For example disabled athletic participants.

The face to face assessments for PIP were degrading, time consuming and challenging for many people.

I would like to see a note that evidence should be up to date, rather than someone producing an old document where the condition may have improved or deteriorated.

Please describe what changes you would make:

I would welcome a more detailed description about the quality of the level ground, eg it may be very difficult to walk on a pebbled surface as against a tarmac surface.

If you proposed changes, what positive impacts could these have, and for who?:

Disabled people are not limited to walking /wheeling on tarmac, to live a full life they need to be able to cross grass / walk on pebbles/ walk on cobbles (eg Edinburgh streets)

If you proposed changes, what negative impacts could these have, and for who?:

I don't see the changes as having a negative impact on the claimant

I agree with the criteria but would suggest including in the description 'planning or undertaking a journey by foot, wheeling, by public transport, taxi, driving.

Many people cannot undertake some or all of these situations and it may be necessary to award points based on the mode of travel not just 'making a journey'. eg a person may be able to get from A to B in a taxi, but not by wheelchair/scooter (if they were physically able to wheel the distance required. eg a blind person could do A to B in a taxi but not on foot as they can't plan the route.

In rural and Island communities buses are infrequent and not adapted for disabled people, there are few footpaths for someone to wheel and the personal experience and opportunity of an islander may affect what they can and can't do.
