# The A887 Invermoriston – Moriston Bridge Trunk Road (Lagain Bhain Bridge Replacement) (Side Roads) Order 2023

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 12(1), (5) and 70(1) of the Roads (Scotland) Act  $1984(\mathbf{a})$  and all other powers enabling them to do so.

In Accordance with section 71(3) of that Act, they are satisfied, as the case requires, that no access to the land is reasonably required or another reasonably convenient means of access to the land is available or will be provided in pursuance of this Order before the accesses are stopped up pursuant to this Order.

In accordance with section 20C and 55A of the Roads (Scotland) Act  $1984(\mathbf{b})$ , they have determined that it is a relevant project falling within Annex II to Directive 2011/92/EU of the European Parliament and of the Council(c), on the assessment of the effects of certain public and private projects on the environment and have published notice of that determination on 17 August 2020.

They prepared an Environmental Impact Assessment Report and published notice of it on 16 May 2023. This Order is made in compliance with the provisions of Parts I and III of schedule  $1(\mathbf{d})$  of the Roads (Scotland) Act 1984.

#### **Citation and commencement**

**1.** This Order may be cited as the A887 Invermoriston – Moriston bridge Trunk Road (Lagain Bhain Bridge Replacement) (Side Roads) Order 202[] and comes into force on [].

### Side Roads and New Means of Access

2. The meanings in schedule 1 of this Order have effect.

3. The Scottish Ministers as roads authority are authorised—

- (a) to stop up those lengths of access described in schedule 2 of this Order where another reasonably convenient means of access to the affected land is available or has been proved pursuant to this Order; and
- (b) to provide those new means of access described in schedule 3 of this Order.

# SCHEDULE 1

## INTERPRETATION

In these schedules—

"the plan folio" means the plan folio comprised of the key plan and the plan SR1 entitled "The A887 Invermoriston – Moriston Bridge Trunk Road (Lagain Bhain Bridge Replacement) (Side Roads) Order 202[]" signed with reference to this Order and deposited at the offices of Transport Scotland, George House 2<sup>nd</sup> Floor, 36 North Hanover Street Glasgow, G1 2AD;

"the existing A887 Trunk Road" means the existing A887 Invermoriston – Moriston Bridge Trunk Road, including all lay-bys and bus lay-bys;

"point A" means the centre point of the existing Allt an Lagain Bhain river crossing of the A887 Invermoriston – Moriston Bridge Trunk Road, shown marked "point A" on plan SR1 in the plan folio.

## SCHEDULE 2

## PRIVATE MEANS OF ACCESS TO BE STOPPED UP

1. The private means of access on the north side of the existing A887 Trunk Road, from a point 40 metres or thereby west, south-west of point A as shown by a solid black bar and numbered "1" on plan SR1 in the plan folio.

### SCHEDULE 3

### NEW MEANS OF ACCESS TO BE PROVIDED

1. From a point 50 metres of thereby south-west of point A in a generally north-westerly, then north, north-westerly direction for a distance of 30 metres or thereby to a point 50 metres or thereby west of point A as shown by single hatching and numbered "2" on plan SR1 in the plan folio.

2. From a point 85 metres or thereby north-east of point A in a generally south-easterly direction for a distance of 15 metres or thereby to a point 90 metres or thereby east, north-east of point A as shown by single hatching and numbered "3" on plan SR1 in the plan folio.
