Thank you for your invitation to respond to the consultation document on the extension of the Scotrail franchise. I am happy for my responses to be made public. I am happy for the Scottish Government to contact me again in the future in relation to this consultation response.

- I believe that the operation of an additional limited stop service from Glasgow to Edinburgh via Shotts along with the extension of 15 minute frequency between Edinburgh-Glasgow best support the delivery of Scotland's railways.
- Q3 I believe that Glasgow crossrail should be the major priced option in the future.
- Q5 There needs to be ticket dispensing machines on every platform.
- Q7 CCTV should be provided in all stations. In addition, schemes to involve local community and heritage groups to regenerate stations should be extended and further funded.
- Q9 Shotts station should be made fully DDA compliant as a matter of urgency. This is particularly important in relation to the proposed limited stop service between Glasgow and Edinburgh via Shotts. It is vital that people with disabilities in Shotts should not be excluded from the opportunities that such an enhanced service will offer.
- Q10 With the absence of a station at Plains on the new Airdrie to Bathgate rail line, provision must be made to ensure that there a good bus links between Plains and the new station at Clarkston
