I am pleased to have opportunity to contribute as MSP for Midlothian to the consultation on initiatives related to the ScotRail franchise extension.

Given that a statement to the Scottish Parliament in August 2008 confirmed that the Waverley Railway line would be operational by the end of 2013, I am very surprised that there is no mention in the document of the operation of rail services on the Waverley line as part of the franchise extension. This is particularly concerning given that the franchise extension runs until November 2014.

I would ask that an explicit commitment is made to the operation of passenger railway services between Edinburgh, Midlothian and the Borders, reflecting the commitment made by Scottish Ministers to Parliament in August.
