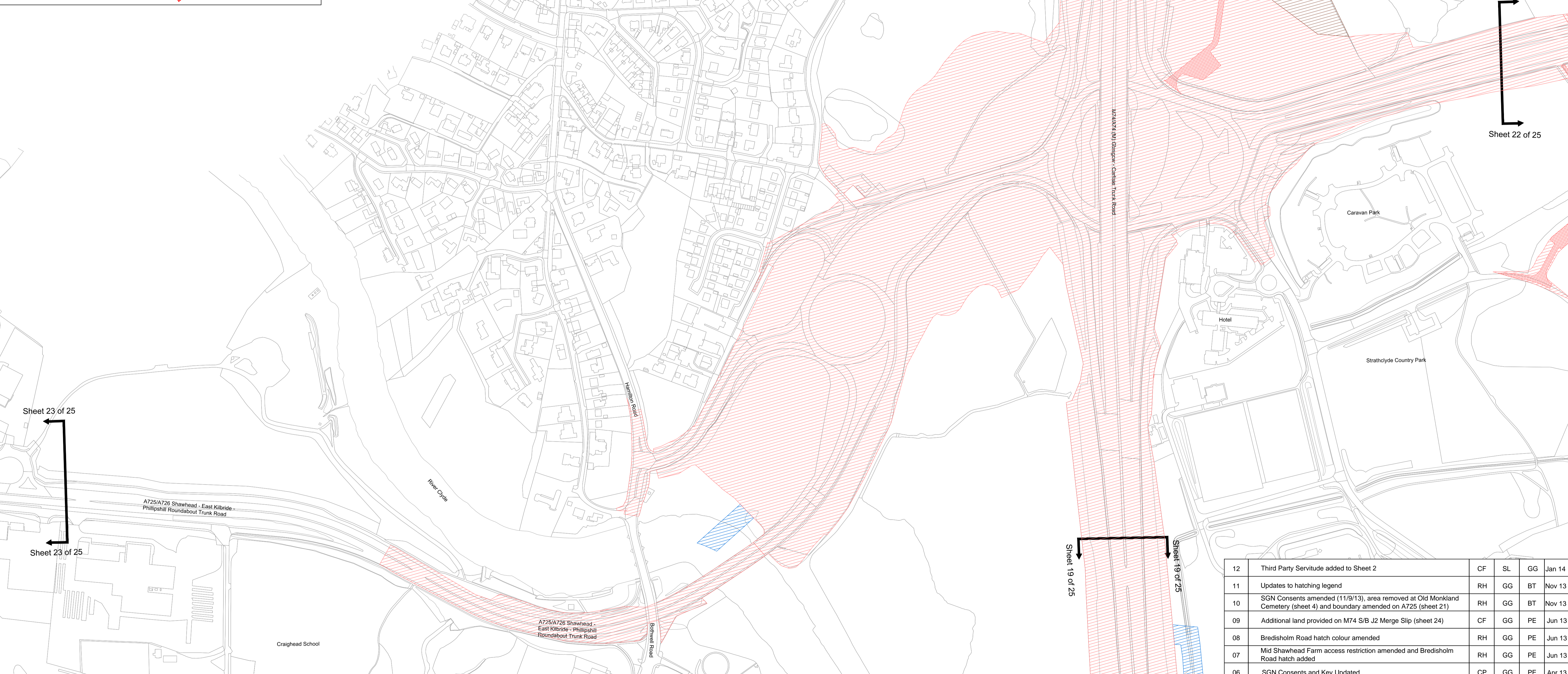


**LEGEND:**
