**The A90 (Aberdeen Western Peripheral Route) Special Road
(Side Roads) Order 2010**

<i>Made</i>	- - - -	<i>11th March 2010</i>
<i>Coming into force</i>	- -	<i>31st March 2010</i>

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 9(1)(c), (d) and (f), 70(1) and 143(1) of the Roads (Scotland) Act 1984(a) and all other powers enabling them to do so.

In accordance with section 9(3) of that Act, they are satisfied, as the case requires, that another reasonably convenient route is available or will be provided before any road is stopped up pursuant to this Order.

In accordance with section 71(3) of that Act, they are satisfied, as the case requires, that no access to the land is reasonably required or another reasonably convenient means of access to the land is available or will be provided.

In accordance with sections 20A(b) and 55A(c) of that Act, they have determined that the project falls within Annex I to Council Directive 85/337/EEC(d) as relevantly amended by Council Directive 97/11/EC(e) and Council Directive 2003/35/EC(f) on the assessment of the effects of certain public and private projects on the environment.

In accordance with sections 20A(2) and 55A(2) of that Act, they have prepared an environmental statement and published notice of it on 11th September 2007 and have complied with all other provisions of sections 20A and 55A of that Act.

This Order is made in accordance with the provisions of Parts I and III of Schedule 1(a) to that Act.

Citation, commencement and interpretation

1.—(1) This Order may be cited as the A90 (Aberdeen Western Peripheral Route) Special Road (Side Roads) Order 2010 and comes into force on the 28th day after the day on which the A90 (Aberdeen Western Peripheral Route) Special Road Scheme 2010(b) is approved by resolution of the Scottish Parliament.

(2) In this Order “the plan folio” means the plan folio numbered RYC/G109/13/0731 and entitled “The A90 (Aberdeen Western Peripheral Route) Special Road (Side Roads) Order 2010”, signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF.

Side roads and means of access

2. The Scottish Ministers as special road authority are authorised—

- (a) to construct those lengths of road (hereinafter referred to as “the new side roads”) along the routes described in Schedule 1;
- (b) to improve those lengths of road described in Schedule 2;
- (c) to stop up those lengths of road described in Schedule 3 when the new side roads are open for through traffic;
- (d) to stop up each private means of access described in column (1) of Schedule 4 when the new means of access described in the corresponding entry in column (2) of that Schedule has been provided;
- (e) to provide those new means of access described in column (2) of Schedule 4;
- (f) to stop up those private means of access described in Schedule 5; and
- (g) to provide those new means of access described in Schedule 6.

Statutory Undertakers

3. Where immediately before the date this Order comes into force there is under, in, on, over, along or across any of the lengths of road described in Schedules 2 and 3 any apparatus of a statutory undertaker, any rights of the statutory undertaker in respect of such apparatus shall be preserved.

Transfer of Roads

4.—(1) On 1st April next after the date on which the new side roads along the routes described in paragraphs 1 to 4 and 32 to 57 and 59 to 64 of Schedule 1 are all open for the purposes of through traffic, those new side roads shall be transferred to Aberdeen City Council(c) as roads authority for those roads.
