1. That length of the Fort William-Mallaig Trunk Road (Route A830) at Corpach in the County of Inverness from a point 50 yards or thereby west of the west (or car park) entrance to the Pulp Mill to a point 130 yards or thereby east of the centre line of East Tom Moine Road, a distance of 1572 yards or thereby.

2. That length of the Fort William-Mallaig Trunk Road (Route A830) in the County of Inverness from the junction with Route A82 in a north-westerly direction for a distance of 340 yards or thereby.

3. Those lengths of the Glasgow-Inverness Trunk Road (Route A82) in the County of Inverness:-

(a) at Fort William from a point 183 yards or thereby north of the junction with Earl of Inverness Road in a north easterly direction for a distance of 1860 yards or thereby;

(b) at Onich from the continuation of the line of the east main gable of Onich Hotel in a westerly direction for a distance of 1000 yards or thereby.

4. That length of the Perth-Inverness Trunk Road (Route A9) at Dalwhinnie in the County of Inverness from a point 30 yards or thereby south of the junction with the private road leading to Loch Ericht and the Hydro-Electricity Board houses in a northerly direction to a point 230 yards or thereby north of the junction with Station Road, a distance of 1000 yards or thereby.

The Trunk Roads (40mph Speed Limit)(Inverness-shire)(Consolidation) Order 1974

28th May 1974

Coming into operation

22nd June 1974

In exercise of the powers conferred on him by section 74(1) and (2) and 84D(1) of the Road Traffic Regulation Act 1967(a) as amended by Part IX of the Transport Act 1968(b) and of all other powers enabling him in that behalf, the Secretary of State hereby makes the following order:-

1. This order may be cited as the Trunk Roads (40 mph Speed Limit)(Inverness-shire) (Consolidation) Order 1974 and shall come into operation on 22nd June 1974.
2. The Interpretation Act 1889(c) shall apply for the interpretation of this order and the orders hereby revoked as it applies for the interpretation of an Act of Parliament.
3. The following orders are hereby revoked:-
 - (a) The Trunk Roads (40 M.p.h. Speed Limit)(Scotland)(No 2) Order 1968(d);
 - (b) The Trunk Roads (40 M.p.h. Speed Limit)(Scotland)(No 4) Order 1968(e);
 - (c) The Trunk Roads (40 M.p.h. Speed Limit)(Scotland)(No 2) Order 1971(f);
 - (d) The Trunk Roads (40 M.p.h. Speed Limit)(Scotland)(No 1) Order 1972(g);
4. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on any of the lengths of road specified in the Schedule to this order.
