1.1 Potential Impacts on Infrastructure, Properties and Cultural Heritage as a Result of Groundwater Dewatering

1.1.1 This appendix provides an assessment of the impact of groundwater dewatering on infrastructure, properties, listed buildings and scheduled monuments and supports Chapter 13 (Geology, Soils, Groundwater and Land Contamination). Data were obtained from review of historical and current maps, Ground Investigation data, consultation and site survey information and presented in Table A13.2-1 based on the likelihood of encountering groundwater in cuttings.
