- 1.3.4 An assessment of non-significant effects on cultural heritage resources during operation is presented in Table A9.6-2. Please note that where the magnitude of impact was assessed to be No Change and the significance of effect was assessed to be Neutral during construction, the magnitude of impact has also been assessed to be No Change and the significance of effect Neutral during operation for the same reasons as identified in Table A9.6-1. The assessment of significance of effect for these cultural heritage resources is therefore not presented in Table A9.6-2.

# 1.4 Mitigation

- 1.4.1 This Section makes reference to overarching standard measures applicable across A9 dualling projects ('SMC' mitigation item references), and also to project-specific measures ('P02' mitigation item references). Those that specifically relate to cultural heritage are assigned a 'CH' reference.
- 1.4.2 Mitigation for potential effects on the cultural heritage resource is presented in Table A9.6-4.

### **Standard Mitigation**

1.4.3 During construction, Standard Mitigation Commitments (SMCs) will be applied in order to mitigate potential impacts on cultural heritage resources (**Mitigation Items SMC-CH01**) (Table A9.6-3). These commitments have been developed for adoption across the A9 Dualling Programme and will be implemented in addition to Pass of Birnam to Tay Crossing project specific mitigation measures detailed as follows.

### **Essential Mitigation**

- 1.4.4 The following mitigation is proposed for non-significant effects on cultural heritage resources. Essential mitigation proposed for significant effects (Mitigation Items P02-CH02 P02-CH09) is presented in Chapter 9 (Cultural Heritage).
- 1.4.5 All mitigation will be undertaken in accordance with relevant guidance provided by the Chartered Institute for Archaeologists (CIfA), HES and Historic England, and a Project Design that will be developed in consultation with Perth & Kinross Heritage Trust and Transport Scotland's Historic Environment Advisor.

#### **Archaeological Remains**

- 1.4.6 Mitigation proposed for non-significant effects on known archaeological remains comprises:
  - archaeological earthwork survey (Level 3) (Mitigation Item P02-CH10);
  - photographic recording (Mitigation Item P02-CH11); and
  - archaeological excavation (Mitigation Item P02-CH03), informed by the results of archaeological trial trenching (Mitigation Item P02-CH02).

The individual cultural heritage resources these mitigation measures are proposed for are identified in Table A9.6-4. Archaeological trial trenching (**Mitigation Item P02-CH02**) will also be undertaken in suitable areas within the CPO where physical disturbance would result from construction of the proposed scheme. Archaeological excavation (**Mitigation Item P02-CH03**) or construction or archaeological monitoring during construction (**Mitigation Item P02-CH12**) would be undertaken of archaeological remains identified by the archaeological trial trenching.

- 1.4.7 During construction, archaeological monitoring (**Mitigation Item P02-CH12**) will be undertaken to make a permanent record of any surviving archaeological remains for the cultural heritage resources identified in Table A9.6-4.
- 1.4.8 All mitigation measures will include a programme of assessment, reporting, analysis, publication dissemination (including archaeological community outreach) of results commensurate with the value of the archaeological remains affected. This will include the preparation of reports which will be submitted to the Perth & Kinross Historic Environment Record and the National Record of the Historic Environment, along with ordered archives which will be submitted to an appropriate repository.

#### **Historic Buildings**

1.4.9 Photographic recording (Mitigation Item P02-CH11) is proposed for non-significant effects on historic buildings to document existing setting prior to construction. The individual cultural heritage resources these mitigation measures are proposed for are identified in Table A9.6-4.

- 1.4.10 A Basic record (**Mitigation Item P02-CH13**) in accordance with the guidance provided in ALGAO Scotland's Historic Building Recording Guidance (ALGAO: Scotland, 2013) is proposed for non-significant effects on historic buildings to document each historic building in their existing setting prior to construction. The individual cultural heritage resources these mitigation measures are proposed for are identified in Table A9.6-4.
- 1.4.11 Mitigation Items P02-CH13 will be undertaken in accordance with relevant guidance provided by the Chartered Institute for Archaeologists, HES and ALGAO: Scotland, and a Project Design that will be developed in consultation with Perth & Kinross Heritage Trust and Transport Scotland's Historic Environment Advisor, and HES and PKC where identified in Table A9.6-4.
- 1.4.12 All mitigation proposed for historic buildings will include a programme of reporting, publication and dissemination of results commensurate with the value of the archaeological historic buildings affected. This will include the preparation of reports which will be submitted to the Perth & Kinross Historic Environment Record and the National Record of the Historic Environment, along with ordered archives which will be submitted to an appropriate repository.

#### **Historic Landscapes**

- 1.4.13 Photographic survey in accordance with the guidance provided in Understanding the Archaeology of Landscapes: A Guide to Good Recording Practice (Second Edition) (Historic England 2017) (Mitigation Item P02-CH14) is required for effects on historic landscapes.
- 1.4.14 The historic landscapes for which **Mitigation Items P02-CH14** is proposed are identified in Table A9.6-4.
- 1.4.15 All mitigation proposed for historic landscapes will include a programme of reporting, publication and dissemination of results commensurate with the value of the archaeological historic buildings affected. This will include the preparation of reports which will be submitted to the Perth & Kinross Historic Environment Record and the National Record of the Historic Environment, along with ordered archives which will be submitted to an appropriate repository.

#### Landscape and Visual Mitigation

1.4.16 The standard and essential landscape and visual mitigation would also help to ameliorate visual impacts on the setting of cultural heritage resources. Please refer to Chapter 10 (Landscape) and Chapter 11 (Visual).
