#### **About MACS**



MACS has a mission.

A **mission** is what we want to do.



MACS mission is to speak up for transport across Scotland that is:



- accessible everyone can use it
- inclusive no one is left out
- possible there are no barriers to stop disabled people travelling



MACS has a vision.

A **vision** is what we want to see happen.



MACS vision is for a Scotland where there is nothing to stop disabled people from travelling from one place to another.



Here are MACS 4 main jobs:



**1.** To give Scottish Ministers advice about the **policies** and laws for disabled people's travel needs.

And to give them advice about what is happening.



**Policies** are lists of rules and agreements.



2. To help more people and organisations in Scotland know about accessible transport.

And about the problems that disabled people have when they travel.



**Accessible transport** is transport that everyone can use.

This means things like pathways and toilets too.




- **3.** To tell the organisations who design and make things like:
  - vehicles
  - buildings
  - timetables

about what disabled travellers need.



**4.** To look carefully at transport work and say what can be better.



MACS has an **impact**.

An **impact** means making change happen.



We have always done important work to make transport better.

We have always made sure that disabled people's voices are heard.

## MACS 5 big aims



MACS has 5 big aims.

These aims are called our **objectives**.



#### **Objective 1**



To make Scotland fairer, more accessible and leave no one out.



#### **Objective 2**

To make sure that having an accessible transport system is part of Scottish Government plans and paperwork.



#### **Objective 3**



To check that the Scottish Government is telling **public organisations** and local councils that they must keep to the laws and rules for making transport accessible.



**Public organisations** are places that give us services – like schools, hospitals and councils.



#### **Objective 4**

To speak up and ask more organisations to talk with MACS about their plans so that they get the best advice about accessibility.



#### **Objective 5**

When we write **reviews** of important travel plans we will speak up for good changes to happen.



A **review** is a close look at something and writing about how well it is going.



We will also speak up for good ways to look after our environment.

This is called **Just Transition**.




Just Transition means working to make sure that disabled people and their journeys are not left out of work on the climate crisis.



The **climate crisis** is the problem of our planet warming up too quickly.

This means our temperatures and weather patterns are changing too fast.
